

D. Membership studies by the Secretary-General

As of October 2019 the membership of ISCARS AH entails the following: 7 on the Bureau; 78 Expert members; 11 Honorary members; 47 Associate members; and 11 Corresponding members. To monitor participation in ISCARS AH activities the Secretary-General keeps a running tally of all correspondence through the ISCARS AH listserv. Participation in ISCARS AH activities is measured not through physical attendance but by responses to queries on the listserv. Monitoring has been taking place since 2013. 4. Complying with the Eger-Xian Principles

As ISCARSAH will be holding an election for officers of ISCARSAH in Sydney 2020, it is time for our committee to bring our present statutes into alignment with the Eger-Xian Principles for International Committees of ICOMOS. Specifically, under criteria B.2 the Principles it states, "Voting at elections of the ISC bureaux as well as on amending the ISC's statutes will be done by Expert Members designated by the National Committee, restricted to one per state." For ISCARSAH to comply with this criteria we will need to determine which Expert Member will represent their state when there are more than one Expert Members per state in many cases. This groundwork will be laid this winter and spring by the Secretary-General.

5. ISCARSAH Activities in 2018

A. Tehran Iran in October

Numerous Activities took place in Iran in October 2018. We owe a debt of gratitude to iscarsah expert member Mehrdad Hejazi for spearheading the development of the training course, workshop and seminar.

Training Course: ISCARSAH held a training course in Tehran, Iran on 20-22 October 2018. All presentations will be published and be made available when publications complete.

Workshop: Along with the aforementioned training course, ISCARSAH held a workshop on "Restoration and Strengthening of Historical Structures" on 23-29 October 2018. The workshop included eleven historic sites in different parts of Iran. The event was organized by ISCARSAH and the Deputy Head of Iran's Cultural Heritage, Handcrafts and Tourism Organization (ICHHTO). The results of this workshop will also be published in the publication for the training course.

Seminar: Following the aforementioned workshop, ISCARSAH members had seminar on "Restoration and Strengthening of Historical Structures" on 29 October 2018 in Isfahan, Iran.

B. Meeting on the Guidelines

ISCARSAH members had a meeting to discuss Guidelines on 7 March 2019 in Barcelona. 26 members attended the meeting that was administered by ISCARSAH Honorary member Pere Roca. Meeting minutes for this meeting have already been distributed to the membership. Revised guidelines will be distributed soon and another meeting will be held in 2020 further refined the ISCARSAH Guidelines.
